HISTORY

Established in 2004, ACE focused initially in the removal and/or installation of Aboveground Storage Tanks (AST), the removal and/or abandonment of Underground Storage Tanks (UST), Tank Compliance, Testing/Compliance of Leak Detection Systems, Tank Cleaning, Oil/Water Separator Cleaning and Site Remediation. These services now represent a major portion of the revenue generated annually.

A year later in October of 2005, ACE expanded to offer Vacuum Truck and Vactor services along with twenty-four (24) hour emergency response. The Emergency Response services include emergency response to spills, accidental releases of pollutants, and other related occurrences. To control and mitigate these emergencies, Ace employs an array of containment, abatement, recovery and/or neutralization measures necessary to control any type of emergency. In addition to controlling the emergency, ACE also provides the means necessary to sample, containerize, remove, and dispose of any contaminants and/or neutralizing agents. Nearly a decade later in 2014, ACE introduced Roll-off Services, as well as Hazardous and Non-hazardous Waste disposal and transportation services. Lastly, in 2017, ACE introduced its very own Storm Water division to respond to the increasing demand for storm water maintenance and inspections.

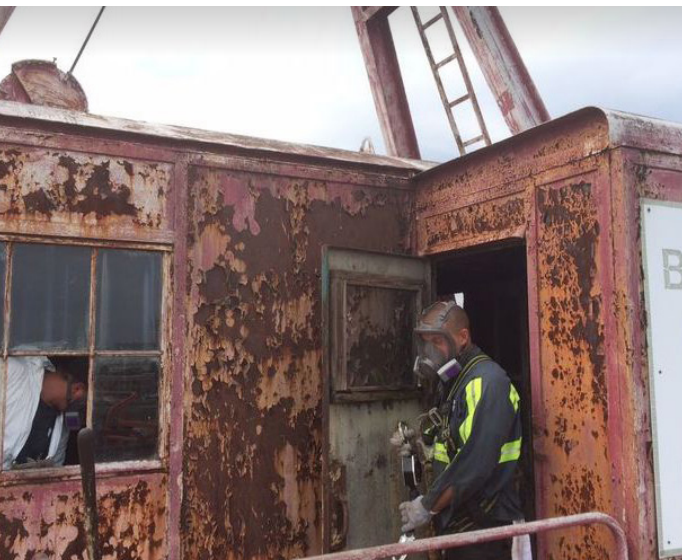
